Poor quality entrants in education sector starts from the primary level of education to secondary and tertiary institutions (Eduardo and Harry, 2023).

The Nigerian state has failed to implement UNESCO and World Economic Forum (2018) for increased educational budget and funding. Due to the lean allocation of funds to education sector there is no positive changes in the system. Studies have shown that nepotism and corruption has bedeviled the management of our public primary education in the country (Ugwulashi, 2017). Some of our private primary schools are doing better, they have well equipped schools delivering academic dividends and have excelled in national and global school competition.

Quality Primary Education

In education, as a measure for comparative index for global competitiveness quality primary education is imperative. TQM theorist deming, Crossby and Juran (2018) were emphatic that quality is what makes an organization survive. In Nigeria as a country if our primary education has to develop there is the need to introduce positive changes into our primary education curriculum. Due to this, the introduction of quality primary education for national development cannot be over emphasized. Crossby maintained that money spent on quality is money that is well spent. Juran postulated that if an organization wants to maintain quality system it must embark on quality planning, quality improvement and quality control (Quality Trilogy). These implies that if quality is to be maintain, cost must not be considered as a factor. Money spent on improving quality is money well spent. Quality planning must be considered. For Nigeria to achieve quality primary education both Federal and State Ministry of Education and Administration of primary education is necessary (Ifesiokwu, 2021).

Management of primary education: In his 21st century education should aim at making grandaunts functionally productive within his or her level of academic attainment and can compete both locally and globally. Every child who acquire primary education should be able to have appropriate and relevant skills and values and to be employable in order to contribute to national development.

Education is concerned with the transmission of skills, knowledge, vocation and culture, this is usually done through teaching, learning, research and dissemination of information for ultimate use. According to the National Policy on Education (NPE 2014)

- i) **Funding:** in order to have quality primary education funding of primary education is very necessary. Inadequate funding of primary education in Nigeria had been reoccurring challenges to the growth of the sector. All the past and present administration in Nigeria lack the political will to find education for the overall development of the country. No government in Nigeria both past and present have meet the UN requirement on education by allocating a minimum of 26% of the country's annual budgetary expenditure to education as recommended by the United Nation scientific and cultural organization [UNESCO] (Ezeanyun, 2017).
- ii) **Planning:** proper planning is an essential tool for putting idea into proper perceptive, absence of proper planning will lead to faulty implementation of any programme or project, quality primary education require proper planning. According to UNESCO (2017) lack of proper planning in Nigeria is due to faulty census exercises. The unrealistic data generated during census exercise has resulted to unrealistic projections of instructional facilities and instructional materials which is needed in primary education system.
- iii) Infrastructural Development: Due to the increase in enrolment of children in primary school, the few available infrastructural facilities are overcrowded, coupled with lack of power supply, computer and internet system. The provision of adequate classroom, block Information and Communication Technology (ICT) etc. depend on provision of adequate funds with these inadequacies primary education in Nigeria will lack the potential for quality education and global competitiveness.
- iv) Instructional Facilities: To attain quality primary education in the country there must be provision for adequate instructional materials, power point, computer and internet services, white board marker, printers, toys and learning game materials etc. these teaching aid help to facilitates teaching and learning especially at primary level of education. These will lead to quality primary education in the country.
- v) **Power Supply:** Different administration both present and past have failed in the area of power supply in Nigeria, just yesterday the nation grid fall and the whole country was in darkness without adequate power supply there will be no

development in the country. Power supply is very essential in the education sector, to attain quality education for global competitiveness power supply is required.
